INTRODUCTION

- In February 2017, at the annual MN PBS Collaborator's Forum, Barry McCurdy from Deveraux Advanced Behavioral Health presented on PBS & PBIS Model in Residential Settings
- In July 2017, DHS Mental Health (now Behavioral Health) Policy Division invited to participate in DHS Direct Care & Treatment - Statewide PBS Leadership Quarterly Meetings.
- September 2017, PRTF providers began monthly meetings
- January 2018, PRTF providers began discussion about development of training plan using PBS framework
- June 2018 1st PRTF Provider began services in Duluth, MN
- July 2018, Behavioral Health Division began work with University of MN Institute for Community Integration (ICI) on co-created process for planning and development of training and technical assistance for residential treatment settings, beginning with PRTF providers
- January 2019, Behavioral Health Division participation in *Intensive PBS Training in Human Services Settings* provided by the University of MN Institute for Community Integration (ICI)
- Engagement with providers by ICI Consultant for initial analysis to review current programs, practices, interventions identified potential target areas and needs



PRTF

- **Psychiatric Residential Treatment Facilities (PRTF) will provide active treatment to children and youth under age 21 with complex mental health conditions.**
- **Inpatient level of care provided in a residential facility rather than a hospital. Deliver services under the direction of a physician, seven days per week, to residents and their families, which may include individual, family and group therapy.**
- **Comprehensive discharge planning is essential for individuals to successfully transition to home, school and community as soon as possible. Discharge planning begins at the time of admission and requires coordination with the individuals, their families and community-based service providers.**
- **Three providers contracted to begin providing service in 2018 – 2019:**
 - Northwood Children's Services opened its PRTF in June 2018. They have a current capacity of 40 beds, with a maximum of 48 anticipated in the future.
 - North Homes Children and Family Services plans to open a PRTF with capacity of 42 beds at their Grand Rapids location. Contingent upon meeting the licensing requirements, North Homes plans to convert 20 beds to a PRTF before July 2019. Phase 2 of the project will be constructing an additional 22 beds starting early summer of 2019.
 - The Hills Youth and Family Services will be building a new facility in East Bethel in 2019. They will begin with capacity of 60 beds.



