# Purpose of the Positive Supports Rule (9544.0005)

- Promote community participation, person-centeredness & inclusion in the most integrated setting
- Focus on creating quality environments;
  - Ensure people are free from humiliating and demeaning procedures;
  - Eliminating the use of aversive and deprivation procedures;
- Ensure collaborative development of positive support strategies;
- Increase skills and self-determination of people receiving services;
- Improve the quality of life of people receiving services;
- Create a consistent set of standards for providers across service settings in serving people with developmental disabilities



#### Where does the positive supports rule apply?

Home and Community Based Services (245 D)

Any person receiving a 245D-licensed service

All other Department- licensed services (245A)

The positive supports rule applies to persons with a developmental disability or related condition \*

### **Summary of Major Provisions**

- Develop/document positive support strategies for every person
- Maintain policy on the Emergency Use of Manual Restraint
- Prohibitions on use of restrictive interventions
- Functional Behavior Assessments
- Positive Support Transition Plans
- Staff qualifications & training
- Report using the Behavior Intervention Report Form



#### **Qualified Professionals and Professional Standards**

- It's important to know that in the PSR the definition of a "qualified professional" varies depending on the license, according to the PSR. Each provider must review the rule and know which professional is qualified to complete assessments and develop treatment plans for the license.
- In addition to professional qualifications, there is an expectation that the professional is competent to develop plans, meet necessary experience requirements, and use commonly known, peer reviewed, evidence-based or otherwise generally accepted professional standards to perform this work.

#### **Positive Support Transition Plan (PSTP)**

Positive support transition plan is the plan required to be developed by the expanded support team to implement positive support strategies to:

- 1. Eliminate the use of prohibited procedures
- 2. Avoid the emergency use of manual restraint
- 3. Prevent the person from physically harming self or others
- 4. Improve the person's quality of life

# Staff Levels Associated with Positive Support Services

- Waiver Positive Support Professional
- Waiver Positive Support Analyst
- Waiver Positive Support Specialist

Each staff level has different qualifications, roles and responsibilities with progressive levels of authority, competency, training, need for supervision and experience. For more information about each staff level, see CBSM – Positive support services staff levels.



### **Positive Support Professionals Tasks**



Complete an individualized functional behavior assessment



Work with the person to develop a person-centered, positive-practice, individualized behavior support plan and/or positive support transition plan



Distribute the plan(s) to the person and his/her team members



Evaluate effectiveness of the service and interventions



Modify the plan(s) as necessary



Provide onsite instructional learning to staff and caregivers about the use of positive supports



Train and supervise waiver positive support analysts and waiver positive support specialists.

### **Positive Support Specialist Tasks**



FUNCTIONAL BEHAVIOR
ASSESSMENT



IMPLEMENT THE PERSON-CENTERED POSITIVE SUPPORT TRANSITION PLAN AND/OR POSITIVE SUPPORT PLAN



COLLECT AND RECORD BEHAVIORAL DATA



COMMUNICATE QUESTIONS
OR CONCERNS TO THE WAIVER
POSITIVE SUPPORT
PROFESSIONAL OR WAIVER
POSITIVE SUPPORT ANALYST.



### Not All Billing is Related to Direct Support....

Some components of positive support services do not involve direct support to the person. The providers may bill the following services and support activities as indirect time to support people:

- Waiver positive support professional: Assessment, development and modification of positive behavior support plans
- Waiver positive support analyst: Overseeing implementation of plans, designing data collection and training staff on data collection
- Waiver positive support specialist: Implementing the plans, collecting and recording behavioral data



#### **Professional Duties of Supervisors and Managers**

Identification of other qualified professionals to help with understanding interfering/target behavior and developing individualized, strength-based positive support strategies.

#### Know when to consult with external qualified professionals!
